Includes annual leave summaries for 1956 and 1957. Also includes receipts for income tax instalment deductions.

Books containing carbon copies of invoice issued. In some case the original invoice is still in the book.

SCH/3 Log Books, 1935-1948

Log Books required to be kept under Regulation 49 (a) of the Forestry Act 1916. In addition to the Name of Mill, Owner, and Situated At, columns recorded information about timber received at the mill: Date of Delivery at Mill Yard or Depot; Docket No.; Name of Hauler; Species of Timber; Consecutive No. of Log or other Timber; Brand; Length; Girth; Deductions; Crown Timber: Contents, Where Obtained; Lease Timber: Contents, Name of Lessee; Private property Timber: Contents, Name of Owner; Rate of Crown Royalty; Remarks.

SCH/3/1 Log Book, 1935-1936

Log Book for G. Schubert's mill at Borganna (variously named "No. 1" and "Borganna") between June 1935 and September 1936.

SCH/3/2 Log Book, 1935-1938

Log Book for G. Schubert's mill at Comboyne (named "Town Mill") between October 1935 and July 1938.

SCH/3/3 Log Book, 1938-1941

Log Book for G. Schubert's mill at Comboyne (name of mill not recorded) between August 1938 and October 1941

SCH/3/4 Log Book, 1941-1942

Log Book for G. Schubert's mill at Comboyne (name of mill not recorded) between October 1941 and October 1942

SCH/3/5 Log Book, 1942-1945

Log Book for G. Schubert's mill at Comboyne (name of mill not recorded) between October 1942 and May 1945

SCH/3/6 Log Book, 1945-1948

Log Book for G. Schubert's mill at Comboyne (name of mill not recorded) between May 1945 and April 1948

SCH/4 Letter Book, 1940-1941

Quarto size book of printed letterhead pages (perforated on left hand side for extraction and mailing), with alternate plain pages for carbon copy of letters as written.

SCH/4/1 Letter Book, 1940-1941

Contains copies of letters written between 12 December 1940 and 6 August 1941. One page of letterhead remains in the book (with the commencement of a letter dates 17 March 1941).
